

Fall 2011 Payment Information

In Person: Monday through Friday 8 am – 5 pm, *unless otherwise posted*

** Please do not make checks out in advance as payment is required in full and cash refunds are not given.*

E-Cashier: Located on the web at www.sandhills.edu. (available through August 8th until 6 pm)

Drop Box: Located on the outside wall of Stone Hall (available through August 8th until 6 pm)

We will mail tuition notices once the legislature has set the tuition rate. We anticipate mailing prior to July 31st.

Payment, including outstanding fines, must be received in full by August 8, 2011 by 6 pm or you will be dropped from your classes.

Financial Aid (Pell)

If you are using financial aid to pay your tuition, your awarded funds will be applied to your charges if your financial aid is complete. Completed financial aid means that you have:

1. Completed a financial aid application (FAFSA)
2. Submitted your official GED or high school transcript
3. Submitted your official college transcript(s) (if applicable)
4. Received an award notification

If you register for Fall 2011 and decide not to attend SCC, you must officially drop your classes. If you do not, you will be responsible for all charges.

Refunds

The business office will process refunds for classes officially dropped through the SCC Course Change form. **Classes dropped before the first day will receive a full 100% refund.** Students will receive **75% refund of tuition only** for classes officially dropped between August 15th and 24th. *Classes dropped after August 24th do not meet the refund criteria.*

ID & Parking Information

Student ID's and parking permits are required for all SCC students.

In order to obtain a student ID, you must show a picture ID (i.e. driver's license).

In order to obtain a parking permit, you must have your vehicle's license plate number and current student ID. **PELL** students may get a student ID beginning August 8, 2011.
