All 50 states, Washington DC, and 4 territories (American Samoa, Guam, Northern Mariana Islands and the US virgin Islands) exclusively use the NCLEX-RN for RN licensure. Puerto Rico allows the use of either the NCLEX-RN or the Puerto Rico Nursing Board of Examiners Exam to qualify for RN licensure. To be eligible to take the NCLEX-RN in any jurisdiction, the educational requirement is to have graduated from a Board of Nursing approved nursing program in one of the member states or territories.

Some states require that a particular body accredit the nursing program. Examples of licensure application requirements (among others) may include submission of an official college transcript, a Social Security number, and a photo ID, driver's license, or passport. Some states require criminal background checks and fingerprinting. Final determination of individual state requirements for licensure by examination can only be confirmed by that state's licensing body.
