PROFESSIONAL LICENSURE NOTES

49 states regulate respiratory care practice, and they all recognize NBRC credentials as the standards for licensure, forming the basis for reciprocity and enabling credentialed practitioners to relocate from one state to another with ease.

Some states require that a particular body accredit the academic program. Examples of licensure application requirements (among others) may include submission of an official college transcript, a Social Security number, and a photo ID, driver's license, or passport. Some states require criminal background checks and fingerprinting. Final determination of individual state requirements for licensure or registry can only be confirmed by that state's governing body.

North Carolina requires a Respiratory Care Practitioner (RCP) license from the North Carolina Respiratory Care Board. Applicants must have completed an accredited program and passed the entry-level examination from the National Board of Respiratory Care.

Sandhills Community College Respiratory Therapy program is accredited by the Commission on Accreditation for Respiratory Care. Graduates of Sandhills' program may be eligible to take entry-level examinations from the National Board of Respiratory Care. Graduates are also eligible for the Advanced Practitioner examination for a maximum of three years after passing the entry-level examination.
