SPECIALTY and FORESTRY CLASSES

Active Shooter (8)

Friday 8:00a-5:00p

Equipment: none required

This course of instruction is designed to prepare the first responder to isolate, distract, and neutralize an active shooter. This course will cover law enforcement and fire and medical response to the scene. The course will culminate with dynamic force-on-force scenarios.

ATF Bombs for First Responders (12)

Saturday 8:00a-5:00p, Sunday 8:00a-12:00p

Equipment: none required

This class takes Emergency First Responders (EMS, Fire, Law Enforcement, and Rescue) through understanding the different types of commercial explosives, explosive compounds, and HME (homemade explosives) understanding how they are utilized. Students will learn techniques first responders can employ to ensure their safety against this new threat. Training will take the first responders through understanding the complexity of IED's, the use of bomb threats, and current terrorist methods, all of which they may encounter in their jobs.

Basic Chainsaw (4)

Friday 6:00p-10:00p

Equipment: PPE

This is a condensed 4-hour course of basic chainsaw safety, correct operation and maintenance of a chainsaw. Topics covered will include safe operation either solo or working with chainsaws around people, correct PPE use and why they are important, correct form, situational awareness, tools that make up a good chainsaw kit to aid in easier use and functionality, and maintenance and tips on keeping the saw running and operating at optimal performance.

Fire Marshal Continuing Education(24)

This course includes 12 hours of fire prevention and code training and 12 hours of fire investigations.

First Due Engine Company—Operations in Multi-Story/Family Occupancies (8)

Equipment: Full PPE

Participants will learn first due operations in multi-story residential to low-rise type structures including; multifamily dwellings, apartment complexes, and motel/hotel structures. The course will cover challenges encountered in building construction, building access, hose-line operations, and tactical considerations, while also focusing on minimal staffing and/or manpower-challenged departments. The course will include classroom training as well as hands-on training covering hose-line stretches for extended preconnected stretches, stairwells, and standpipe operations.

Mental Health Peer Support (8)

This course is designed for the rural fire department firefighter as a supplement to his/her regular training program as outlined in NFPA pamphlet 1001. This course is designed for both the firefighter with little experience and the firefighter with experience in wildland fires, who are not full-time wildland firefighters and are limited to small unit initial attack units.

This course is designed to cover initial response objectives to a hazardous materials incident. This block will present the candidate with the knowledge, skills, and ability to satisfy the requirements of OSHA 1910.120 and Chapter 4, 5, 6.2, and 6.6 of NFPA 1072: Standard for Hazardous Materials/Weapons of Mass Destruction Emergency Response Personnel Professional Qualifications (2017 ed.).

TIMS (4)

This course is designed to establish the foundation for and promote consistent training of all responders to achieve the three objectives of the Traffic Incident Management (TIM) National Unified Goal: responder safety; safety, quick clearance from incidents; and prompt, reliable, interoperable communications. This course will familiarize fire and rescue personnel with the purpose of the Strategic Highway Research Program 2 (SHRP2) and National TIM Responder Training Program and how it relates specifically to North Carolina. Participants will learn to recognize and identify the dangers encountered by emergency responders working in or near traffic. This course is not a state fire & rescue certification course; however, it is a requirement related to one or more state certifications and will transfer electronically to the Office of State Fire Marshal (OSFM) for inclusion on OSFM transcripts.

After successful completion of this course candidates will receive the Fire & Life Safety Educator I Fire and Rescue Commission IFSAC Certification. Pre-requisite(s) The candidate must be at least 18 years of age. The candidate must have a high school diploma or equivalent (i.e., GED). TIMS (FIP 7000) **Limited seats available.**

ICS CLASSES

ICS 300 (18)

FEMA Certification

Prerequisites: ICS 100 & 200

ICS-300 provides an in-depth focus on the NIMS Incident Command System (ICS) that includes the tools, practices and procedures that are available in ICS to effectively manage emergency incidents or planned local events at a local Type 3 level. Expanding upon ICS-100 and -200, this course ensures that responders understand the basic ICS concepts that allow an incident management organization to expand and contract as needed to fit the incident and maintain its operational effectiveness. **FEMA student identification (SID) number required.**

ICS 400 (16)

FEMA Certification

Equipment: none required

Prerequisites: ICS 300

ICS-400 provides training and resources for responders who require advanced application of the ICS by providing overall incident management skills rather than tactical expertise. Expanding upon information covered in ICS-100 through ICS-300 courses, ICS-400 emphasizes large-scale organizational development, roles and relationships of the command and general staff, and planning, operational, logistical and fiscal considerations related to large and complex incident and event management. The course also describes the application of Area Command and the importance of interagency coordination on complex incidents and events. **FEMA student identification (SID) number required.**

OFFICER CERTIFICATION CLASSES

Fire Chief 101 (8)

This certification-related course is designed to apprise chief officers of the various aspects and complexities surrounding the operations and organization of North Carolina Fire departments. Emphasis will be placed on ratings and inspections, NFIRS reporting, prevention and relief funds, grant programs, basic line of duty death information, various state associations, and an overview of chief officer expectations in North Carolina. This class will satisfy the 9S insurance inspection criteria as specified by the North Carolina Administrative Code.

This certification-related course is designed as an update to the Fire Chief 101 Course. Course content is revised on a five-year cycle so that chief officers receive the most relevant and current information available.
