

Insurance Pre-licensing information

SCC offers a variety of insurance pre-licensing courses that include Life, Health, Medicare Supplement/Long term care, Property, Casualty, Personal Lines, and Adjuster. Students interested in taking insurance pre-licensing courses can choose from two online delivery options: Synchronous or Asynchronous classes. SCC's insurance pre-licensing classes are done in partnership with Insurance Educational Systems, an approved educational provider with the Department of Insurance.

Description of classes:

Property & Casualty Pre-Licensing

This course is designed to prepare you for the N.C. State Property & Casualty Insurance Agents Examination. There is a 40-hour study requirement by DOI, 20 hours for Property and 20 hours for Casualty. The study requirements will be met with the video, quizzes and study recommendations on the video.

Property Pre-Licensing

This course is designed to prepare you for the N.C. State Property Insurance Agents Examination. There is a 20-hour study requirement by DOI that will be met with the video, quizzes and study recommendations on the video.

Casualty Pre-Licensing

This course is designed to prepare you for the N.C. State Casualty Insurance Agents Examination. There is a 20-hour study requirement by DOI that will be met with the video, quizzes and study recommendations on the video.

Life & Health Pre-Licensing

This course is designed to prepare you for the N.C. State Life & Health Insurance Agents Examination. There is a 40-hour study requirement by DOI, 20 hours for Life and 20 hours for Health. The study requirement will be met with the video, quizzes and study recommendations on the video.

Life Pre-Licensing

This course is designed to prepare you for the N.C. State Life Insurance Agents Examination. There is a 20-hour study requirement by DOI that will be met with the video, quizzes and study recommendations on the video.

Accident/Health Pre-Licensing

This course is designed to prepare you for the N.C. State Accident/Health Insurance Agents Examination. There is a 20-hour study requirement by DOI that will be met with the video, quizzes and study recommendations on the video.

North Carolina Medicare Supplement/Long Term Care

This course is designed to prepare you for the N.C. State Medicare Supplement/Long Term Care Insurance Agents Examination. There is a 10-hour study requirement by DOI that will be met with the video, quizzes, and study recommendations on the video.

Property & Casualty Adjusters Pre-Licensing

This course is designed to prepare you for the N.C. State Property and Casualty Adjusters Examination. There is not a pre-licensing study requirement by DOI; however, students studying this adjuster specific course will increase the probability of passing the state exam. The course includes a video, quizzes and study recommendations on the video.

Personal Lines Pre-Licensing

This course is designed to prepare you for the N.C. State Personal Lines Insurance Agents Examination. The minimum recommended study time is 40-hours. The difference between the Property and Casualty and this course is the Commercial section. Personal Lines does not include the Commercial section on the state exam. The study requirements will be met with the video, quizzes, and study recommendations on the video.

Asynchronous Classes

Asynchronous classes can begin at any specified time of the month that is agreed upon between the student and the Coordinator of Workforce Licensure. Students will have 60 days to complete their asynchronous course. Students will be contacted via email and/or phone call to discuss their start date of class. These classes are self-paced and include video streaming activities. The cost of these classes is significantly lower due to the video nature of the class, but this option allows you to watch videos multiple times to review the material. Instructors are available on-call to address student questions. Costs of these classes are as follows:
